- We established and grew Industrial Advisory Board with a total of nine members from multinational companies and various national societies, including France, Australia & New Zealand, South Africa, Thailand, Spain, Singapore, South Korea, and Japan; and the members represent industry sectors including the mining, chemicals, materials, energy etc. (see attached chart on page 4).
 - We established core coordinators' group with a total of five members from various national societies, including Austria, China, Scandinavia, Singapore, and Thailand, which also serves as the pool for future leaders of the CEEM committee.
 - We discussed the following key topics:
 - Royalties survey in collaboration with LES US/Canada;
 - Webinars - "Chat with CEEM Champions";
 - Collaboration with WILA on webinars;
 - Standard briefing notes on best practice, hot topics, and recent trends in the CEEM fields;
 - Increasing the membership of the CEEM committee;
 - Attracting more members to join the Industrial Advisory Board.
 - Collaboration with LES US/Canada on royalties survey
 - We were involved in the planning, promotion, and execution of the royalties survey;
 - Our Industrial Advisory Board members provided revisions and comments regarding the questions for the survey;
 - We confirmed two silver sponsorships for the survey: one is from SCG Chemicals (one of the Industrial Advisory Board members' company) and another is from Finnegan (the firm Ningling works with).
 - We had three teleconference calls with the Industrial Advisory Board members in August and November 2021, and February 2022, respectively. Our next teleconference call with the Industrial Advisory Board members will be at the end of May 2022. We also had two teleconference calls with the coordinators in August and November 2021, respectively. Our next teleconference call with the coordinators will also be at the end of May 2022.
 - We confirmed and organized State of Industry Briefing on Energy and Green Technology for LESI Annual Meeting to be held in Venice, Italy, on May 9-10, 2022. We also worked with Ms. Madelein Kleyn for the concurrent workshop on energy transformation for the LESI Annual Meeting.
 - We worked with the LESI Board and LES Portuguese/Spain, establishing a plan for a global energy forum and the infrastructure thereof.
 - We published an article "*Protection, Enforcement, and Licensing of Trade Secrets in view of the COVID-19 Pandemic*" with *les Nouvelles*.
