We have started talks to participate in the celebration of IP Day together with the local Trademak Agents Association that is scheduled to take place in late April.

Les Chile has asked LES LATAM for help in the organization of a Roundtable on "Nueva Constitución, innovación, propiedad intellectual y transferencia". We have to approach our members to try engage a speaker active in innovation and public policies.

We are still making efforts to put up a seminar with the new head of Tech Transfer at INPI. The submission proceedings are now totally conducted online and these last two years have requested lots of effort on the part of the authorities and users to make the system work. We are still facing very long registration terms and hope to use a possible discussion as a means to help INPI to understand users' concerns.

#### How can LESI or other LES Societies further support you?

We have strong ties with the rest of the Latam societies and that has allowed us to join efforts to put up panels and participate in meetings. Last year, upon a proposal put forward by Karina Muller from Les Brasil, we launched the LES Latam name and project. Verónica Canese, from LES Argentina, participated in 2021 in a Small table at the LESI Annual Conference entitled "Top Female Challenges on Early Career" as well as in a Training session organized by Les Brazil for their INPI that took place in July.
